The Yemen Red Sea Ports Corporation (YRSPC) has get Governmental finance toward the cost of The Tender of **New Container Terminal Berths and Deepening the Access Channel Project for Hodeidah Port** and intends to prequalify

contractors (and/or firms for following works through International Competitive Bidding which this Invitation for Prequalification is issued.

Title of Work : **"New Container Terminal Berths Project and Deepening The Access Channel Of Hodeida Port"**

Scope

The works include the construction of Quay Walls, Deepening of Navigation Chanel, Turning basin, new container terminal, buildings, Fences, and Utilities.

The successful Bidder shall be invited to submit Technical and Financial offer for the construction of "**New Container Terminal Berths Project and Deepening the Access Channel of Hodeidah Port**" (NCTBP), Republic of Yemen. The Works consist of:

- Berth length (600m) with design depth (-16m);
- The deepening of the access channel, the creation of a new turning basin in front of the new container terminal and berth basin to -12m;
- A 200,000 m² container stacking yard with pavement and utilities ;
- A 1100 m long access road connected to the port road network;
- Facilities and Infrastructures for the new container terminal;
- Dredging , reclamation of land and disposing of contaminated materials ;

General

- The Applicant should have relevant experience in at least one project of similar nature during the last five years.
- The construction period is (36) months,
- Prequalification will be governed by the GOY guidelines for procurement, and procedures of the Yemen High Tender Board.
- A complete stamped original set of Prequalification Document in English language can be obtained by interested applicants upon submission of a written request at the address mentioned below.
- Digital (PDF formatted) copy of the Prequalification Document is available. However, Applicants must obtain Stamped Original Prequalification Document from the address mentioned below and return it with the Applicant submitted documents.
- Application for Prequalification should be submitted in sealed envelope, delivered to the address mentioned below by 11:00 AM before day Wednesdays (11 /9 /2013), documents which are received late shall be rejected and returned unopened. Also, applications submitted should be stamped on original set or otherwise will be rejected.
- Prequalification analysis will be conducted through prequalification procedures according to the Prequalification Document; Applicants will be advised, in due course of the result of their Applications.
- Applicants are allowed to cooperate or enter into joint venture with specialized firms or suppliers to cover the required integrated scope. The number of firms cooperating together shall not exceed **three** firms.
- Only firms and joint ventures pre-qualified under this procedure will be invited to bid.
